<p>Educational Requirement: LCPC / Conditional LCPC</p> <ul style="list-style-type: none"> • Master's degree or higher from a regionally accredited institution that consists of 60 semester hours and is CACREP accredited, or consists of coursework in 10 core areas, 3 additional areas, and a practicum and internship of 900 clock hours. <p>LPC / Conditional LPC</p> <ul style="list-style-type: none"> • Master's degree or higher from a regionally accredited institution that consists of 48 semester hours and is CACREP or CORE accredited, or consists of coursework in 10 core areas and a practicum and internship of 600 clock hours. <p>Experiential Requirements: LCPC</p> <ul style="list-style-type: none"> • 2 years/3,000 hours of postmaster's supervised clinical counseling experience.
