## Counseling Licensure Requirements: Pennsylvania

Educational Requirement:	
<ul> <li>Successful completion of a planned program of 60 semester hours (or 90 quarter hours) of graduate coursework in counseling or a field closely related to the practice of professional counseling, including a 48 semester hour (or 72 quarter hour) master's degree in professional counseling or in a field closely related to the practice of professional counseling.</li> <li>OR</li> <li>Doctoral degree in counseling or in a field closely related to the practice of professional counseling.</li> <li>AND for both:         <ul> <li>Completion of coursework in 9 core areas including a supervised practicum (100 hours) and internship (600 hours). The supervised internship experience shall begin after completion of the supervised practicum experience.</li> </ul> </li> <li>Experiential Requirements:         <ul> <li>3 years/3,600 hours of supervised clinical experience after completing 48 graduate level credits (or 72 quarter hours). (Have to complete at least 600 hours a year and no more than 1,800 a year)</li> <li>If obtained a doctoral degree in counseling: 2 years/ 2,400 hours of supervised clinical experience. 1 year/ 1,200 hours must be obtained post degree.</li> <li>Supervision must be provided by a qualified supervisor. At least 1,800 hours must be completed under an LPC that has 5 years of experience within the last 10 years as a professional counselor. There should be 2 hours of supervision for every 40 hours of client hours.</li> <li>The remaining hours may be completed under an individual that holds a license and has at least a master's degree in a related field and 5 years of experience within the last 10 years in that field.</li> </ul> </li> <li>Exam Required: Any ONE of the following: NCE CRCE ATCB CBMT PEPK AODA EMAC</li> </ul>	<ul> <li>Earn a graduate degree</li> <li>Complete 3600 hours of supervised clinical work experience</li> <li>Take the National Marital and Family Therapist Examination</li> <li>http://www.dos.pa.gov/ProfessionalLicensing/Pages/default.aspx</li> </ul>
