

## Counseling Licensure Requirements: Vermont

<b>Licensed Professional Counseling</b>	<b>Marriage and Family Therapy</b>
<p><b>Educational Requirement:</b></p> <ul style="list-style-type: none"> <li>• Master's degree or higher in counseling from an accredited institution, with a minimum of 60 semester hours and 700 hours of a supervised practicum, internship, or field experience in a clinical mental health setting. (Master's degree must be 48 semester hours and "CACREP equivalent".)</li> </ul> <p><b>Experiential Requirements:</b></p> <ul style="list-style-type: none"> <li>• 2 years/3,000 hours of postmaster's experience in clinical mental health counseling, including 2,000 hours of direct client contact.</li> <li>• 100 hours of face-to-face supervision required.
